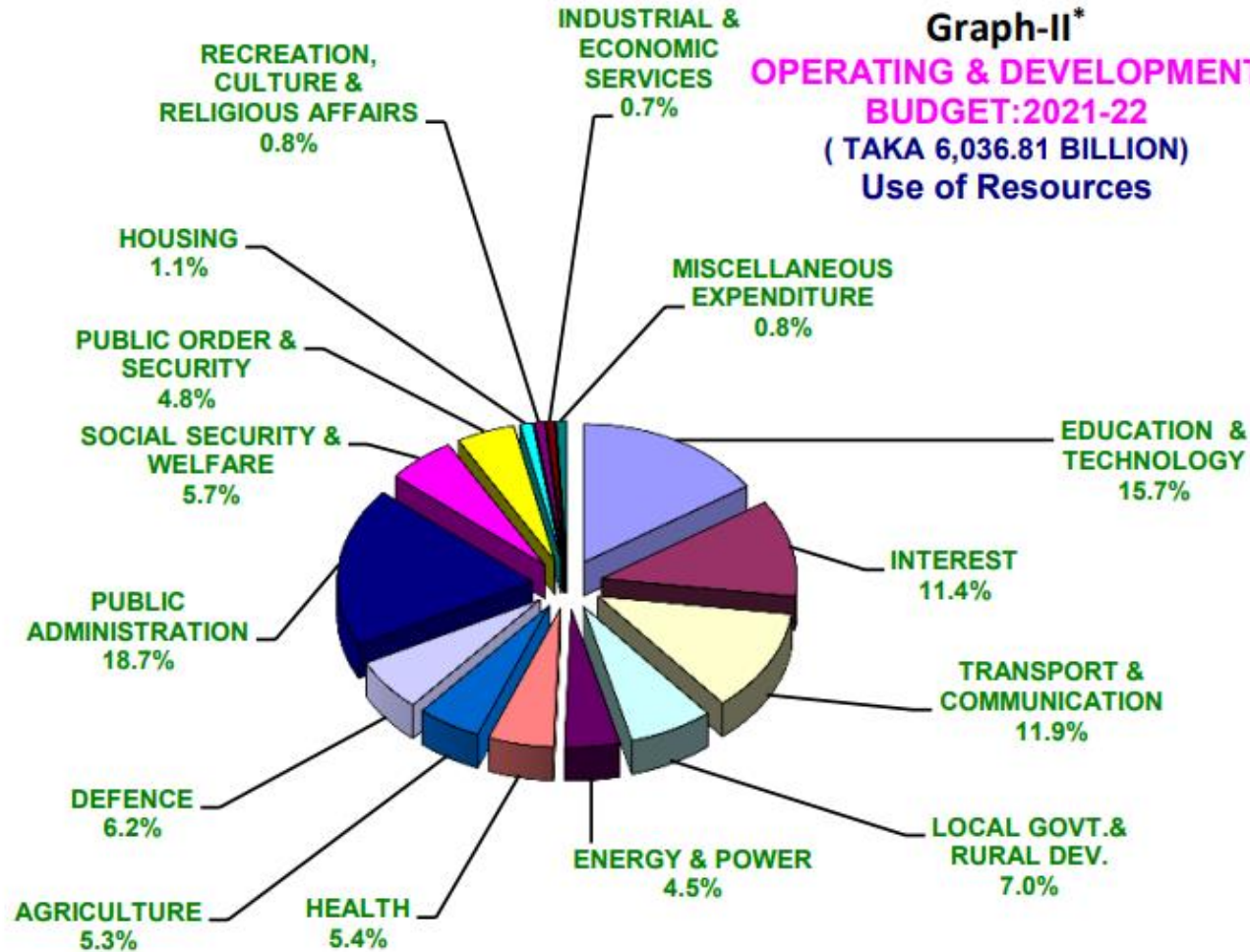

OPERATING & DEVELOPMENT BUDGET:2021-22

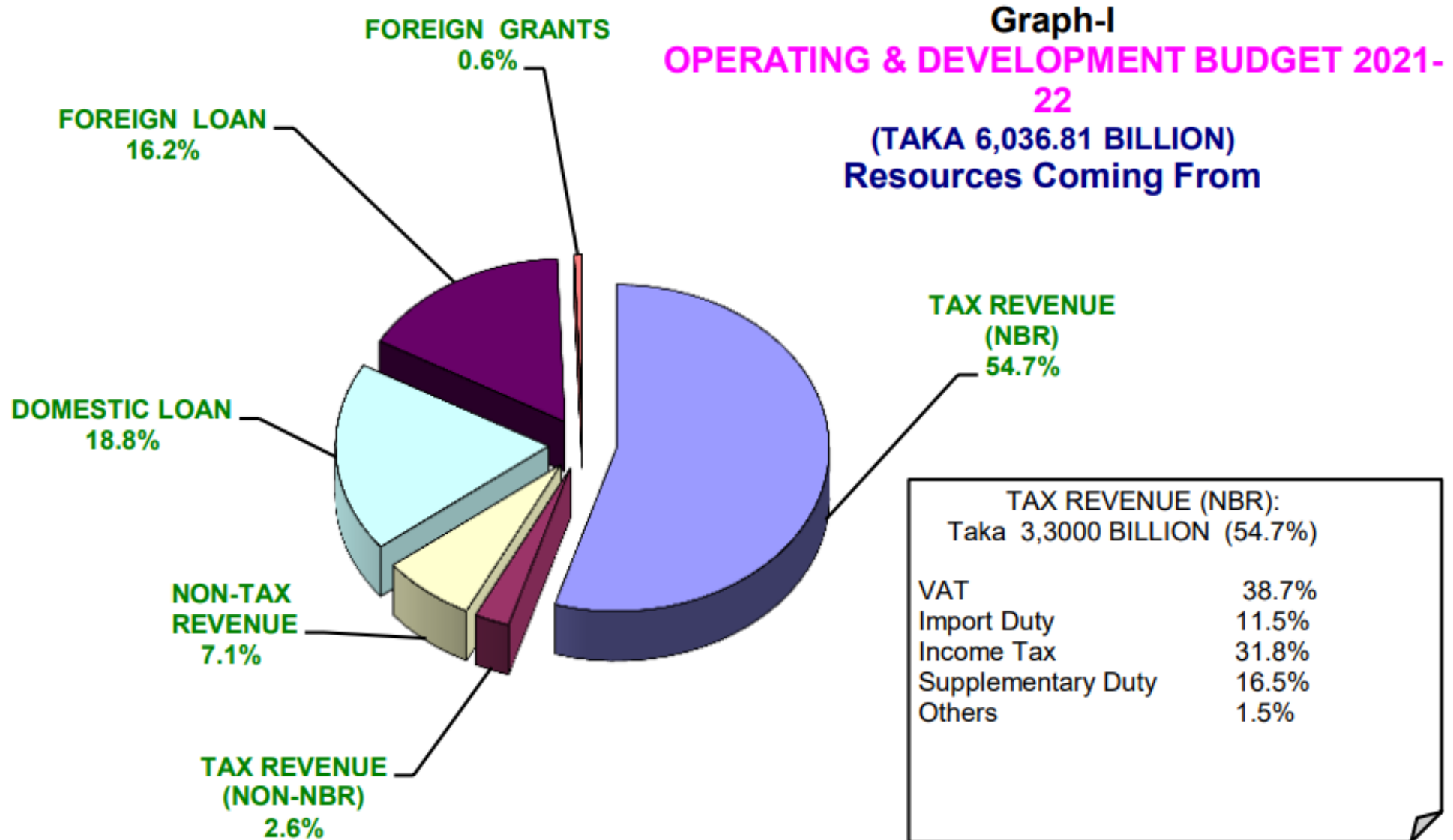
